The Kenwood Fire Protection District serves 4000 residents over a forty square mile area. We carry an Insurance Services Office (ISO) rating of 4/4Y.

Situated in the northern portion of the Sonoma Valley sixty miles north of San Francisco in one of the premiere grape growing regions in the world we are home to many world class wineries.

Kenwood Fire Protection District employs 2 full time Fire Captains, 2 full time Engineers and a full time Fire Chief. We are also supported by an Assistant Fire Chief, 2 Volunteer Fire Captains and part time Firefighters and Firefighters who serve on a Paid/On Call basis. All have graduated from fire academy and train and drill regularly.

Kenwood Fire Protection District's Mission is to acquire and maintain at the highest possible state of readiness, adequate resources of manpower, equipment and other related facilities, to enable prompt and efficient response to emergencies that threaten human safety and property.

A Part-Time Firefighter must meet the minimum certification and educational requirements as prescribed by the Fire District.

- EMT Certification
- Driver Operator 1A
- Valid California Class C Driver's License with Firefighter Endorsement or Equivalent

THE PROGRAM

- 24 Hour shifts available. Limited to 1000 hours a year. Strike Team/Task Force opportunity.

- Compensation - \$19.24 per hour (starting July 1st, 2022) with 1 hour of sick leave for every 30 hours worked.
- Respond to fire and medical emergencies and follow instructions of superiors of standard procedures in laying hose, advancing and flowing hoselines, using ladders, performing rescues, ventilation, salvage, clean-up work; administer first aid via BLS; clean, test, and maintain equipment, buildings, quarters and grounds; participate in drills and other training activities; participate in fire prevention inspections. May operate and drive fire apparatus and specialized fire equipment.
- Part-Time employees are considered to be “At Will” employees who work no more than 1000 hours in a fiscal year. Part-Time employees do not receive health or retirement benefits. Part-Time employees will be paid hourly for drills and after hour calls.
